

STANDARD RELEASE FORM

The Agile Brand, LLC (“**Company**”) desires to host the undersigned individual (“**me**” or “**I**”) as a guest on the Company’s podcast (the “**Appearance**”), and in furtherance thereof, desires to interview and record me, and to use and publicize my name, likeness and other characteristics for the purpose of advertising and promotion of the Appearance, and other commercial and business purposes (“**Purposes**”).

For the intangible value I will gain through the Appearance, and other good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge, I irrevocably grant Company permission to film, record, and photograph the Appearance (the “**Recording**”), and to use the Recording, and my name, likeness, and other personal characteristics and information for the Purposes, according to the terms and conditions set forth in this Standard Release Form (“**Release**”). Notwithstanding anything contained to the contrary herein, the Company shall have no obligation to use, exploit, sell or distribute any portion of the Appearance, the Recording or Information (as defined below).

I hereby irrevocably permit, authorize, and license Company and its affiliates, successors, licensees, agents, and assigns (“**Authorized Persons**”) to (i) digitize, modify, alter, edit, adapt, create derivative works, display, publicly perform, exhibit, transmit, broadcast, reproduce, exploit, sell, rent, license, otherwise use and distribute, and permit others to use and distribute the Appearance, and the Recording, including my name, image, likeness, appearance, and voice as they appear in the appearance and/or Recording, on a perpetual basis throughout the world, in any medium or format whatsoever whether now existing or hereafter created, including without limitation internet streaming and downloading, websites, other digital transmission methods, mobile applications, television broadcast, cablecast, satellite, home video, video on demand, pay television, pay-per-view, radio, and print publications (collectively, “**Medium**”), on any platform whatsoever whether now existing or hereafter created (collectively, “**Platform**”), and in connection with any and all ancillary products, including without limitation merchandise, books, and software applications, without further consent from or any royalty, payment, or other compensation to me except as otherwise expressly provided in this Release; and (ii) use and distribute, and permit others to use and distribute, my name, likeness, appearance, voice, professional and personal biographical information, including all statements, quotes and information provided during the Appearance (collectively, “**Information**”), on a perpetual basis throughout the world, in any Medium or Platform, in either case (i) or (ii) without further consent from or any royalty, payment, or other compensation to me.

I agree that Company is and will be the sole and exclusive owner of all right, title, and interest in and to the Appearance, the Recording, and the Information, including without limitation all copyrights and other intellectual property rights therein, in perpetuity throughout the universe. In furtherance of the foregoing, I agree that the results and proceeds of my services in connection with the Appearance and Recording are works made for hire for Company as defined in Section 101 of the Copyright Act of 1976. To the extent the Appearance, the Recording, the Information, or any part thereof does not qualify as, or otherwise fails to be, a work made for hire, I shall, and hereby do, (a) assign, transfer, and otherwise convey to Company, irrevocably and in perpetuity, throughout the universe, all of my right, title, and interest, if any, in and to the Appearance, the Recording, the Information, including without limitation all copyright and other intellectual property rights (which shall include, without limitation, all registration, renewal, and reversion rights) and the right to register and sue to enforce such copyrights against infringers; and (b) irrevocably waive any and all claims I may now or hereafter have in any jurisdiction to so-called “moral rights” or rights of droit moral in the Appearance, the Recording, the Information.

I represent and warrant that (i) I am at least 18 years of age, and I have the full right, power and authority to enter into this Release and grant the rights granted hereunder; (ii) the Company’s publication of the Information as authorized herein will not violate or infringe any copyright, trademark, or other intellectual property or proprietary right of any person or entity, (iii) I am not a party to and the Information is not subject to any contract or arrangement which would conflict with my Appearance, the disclosure of Information, or the terms of this Release; and (iv) I will only provide true and correct Information during the Appearance. I hereby agree to defend, indemnify, and hold harmless the Authorized Persons from and against all liabilities, claims, demands, actions, suits, damages, and expenses asserted by third parties resulting from my breach of this Release or any of the foregoing representations and warranties.

This Agreement shall be governed by, and construed in accordance with, the laws of the State of Virginia. The Company and I irrevocably submit to the exclusive jurisdiction of the courts situated in Arlington County, Virginia for any dispute arising directly or indirectly out of this Agreement or my Appearance.

This Release is my complete understanding regarding the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, regarding such subject matter. If any term or provision of this Release is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability will not affect any other term or provision of this Release or invalidate or render unenforceable such term or provision in any other jurisdiction. Company may assign this Release and its rights hereunder, in whole or in part, to any party. This Release will be binding on and will inure to the benefit of Company and me and our respective successors and assigns.
